6. CATEGORIES:

Categories including; Education & Business and Retail & Business (Slaney and Suir) - Exhibitors are positioned within a framed marquee. Overall dimension of marquee is 20m frontage by 35m depth. 44 **units in total in marquee.** Stand units consist of two side walls and a back wall. There is an exemption to units positioned on a corner. These are open on 2 sides, have one side wall and a back wall. Dimensions of units are 3metres by 3metres. Internal dimensions of unit measure 2.85metres by 2.85metres, 2.5 metres in height. Opening of each double doorway measures 3metres by 3metres. Four doorways in total. There are a limited number of shell units (4 in total) measuring 2 metres by 3 metres. Internal dimensions of 1.9 metres by 2.85 metres. Two of these units exist in each marquee. They are positioned to the right and left on entry to the marquee.

Categories Including; Health & Wellness and Retail & Business (Dolmen) - Exhibitors are positioned within a framed marquee. Overall dimension of marquee is 20m frontage by 45m depth. **56 units in total in marquee** - Stand units consist of two side walls and a back wall. There is an exemption to units positioned on a corner. These are open on 2 sides, have one side wall and a back wall. Dimensions of units are 3metres by 3metre4s. Internal dimensions of unit measure 2.85metres by 2.85metres, 2.5 metres in height. Opening of each double doorway measures 3metres by 3metres. Four doorways in total.

Agriculture Pavilion – marquee measures 9metres by 18metres. **12 Units in total in marquee.** A row of stand units on both sides with an avenue down the centre. Two double doors, one to the front, and the other to the back. Door opening measures 3 metres by 3 metres.

Categories including; Food & Beverages, House & Home, Lifestyle & Tourism, Retail & Business – The Dome Exhibitors are positioned within a framed marquee. Overall dimension of marquee is 65m frontage by 30m depth. **114 units in total in marquee.** Stand units consist of two side walls and a back wall. There is an exemption to units positioned on a corner. These are open on 2 sides, have one side wall and a back wall. Dimensions of units are 3metres by 3metres. Internal dimensions of unit measure 2.85metres by 2.85metres, 2.5 metres in height. Opening of each double doorway measures 3metres by 3metres. Eight doorways in total.
